The London School of Economics and Political Science, the WZB Berlin Social Science Center, and the European University Institute invite submissions for the third European Junior Faculty Forum for Public Law and Jurisprudence to be held at the London School of Economics and Political Science on June 10-11, 2019.

Objective

The forum addresses public law scholarship from an interdisciplinary and comparative perspective, contributes to the research of junior scholars, and creates an intellectual community of European public law scholars. Public law focused scholarship from other disciplines (philosophy, political science, history, sociology) is particularly welcome. The European Junior Faculty Forum for Public Law and Jurisprudence aspires to become the leading forum in Europe for rethinking public law questions and generating innovative ideas.

Format

The forum is modeled on similar forums in North America, such as the Yale-Stanford-Harvard Junior Faculty Forum. It brings together a selected group of early career scholars for what promises to be an intellectually rewarding academic exchange. The papers, selected by blind peer-review, will be presented in a workshop to be held at the LSE. Two senior scholars will serve as commentators on each paper, providing critical feedback and suggesting ways to improve the paper. There is no publication requirement, though the *Modern Law Review* reserves the right of first refusal on papers.

Eligibility

The author must be based in an academic institution in the European Union or in an Associated Country* and have obtained the doctoral degree no longer than seven years prior to the application deadline (excluding periods of maternity/paternity leave and/or career breaks for other caring responsibilities). Postdoctoral students are also eligible to apply. Authors who live or work outside the EU or an Associated Country are eligible to apply provided that they hold a junior faculty position (or the equivalent) in Europe. Co-authored papers are welcome if each author is individually eligible. Papers must be original and should not have been accepted for publication before to the workshop; they can focus on any topic relating to public law and jurisprudence, broadly defined, from legal or non-legal perspectives.

Procedure

Interested scholars should submit (in English, three separate PDF files) a CV (up to 3 pages), an abstract (up to 300 words), and a draft article (8,000 to 15,000 words, including footnotes) to ejff@wzb.eu by **April 7, 2019**. Please remove any reference to the author's identity in the draft article. Decisions will be sent by April 29, 2019. The workshop will be held on June 10-11, 2019 at the London School of Economics and Political Science in London.

The European Junior Faculty Forum will reimburse costs of travel and accommodation for participants selected for the London event up to a maximum of 500 Euro.
